1. The Vyas Municipality invites *electronic* bids from eligible bidders for the procurement of under mentioned Works *under National competitive bidding procedures specified in Public Procurement Act and Regulations.*
2. 3. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below. Bid security amount of the sealed bids should be as mentioned on the table below for each bid and the eligible bidder should submit the original voucher with bid document or submit equivalent bank guarantee from Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law having validity period of 120 days for sealed bid in the following Security deposit (Dharauti) account as specified below.

4. Electronic bids must be submitted to the Vyas Municipality Office, Damauli, Tanahun through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on 2077/07/21 (06th November, 2020) for sealed bids. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM, 2077/07/21 (06th November, 2020) for electronic bids at the Vyas Municipality Office, Damauli, Tanahun. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of mentioned below, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days)
6. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The bidders who submitted their bids electronically through e-procurement section of PPMO's website www.bolpatra.gov.np/egp, the bidders may submit hard copy of bids not later than 5 days of the opening of bids or quotations i.e. before 2077-07-26 (11th November, 2020) for bids.
8. The Employer reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.
9. Any intimidation, collusion and curtailing during bidding process shall be punishable by law.
10. Other matters regarding the bidding process should be as per prevailing law of Government of Nepal.
